That the decedent, MARILYN CORRINE WREN, died on October 20, 2019, in Carson City, Nevada, and left an estate in the State of Nevada subject to administration.

ACCOUNTING

That, pursuant to NRS 150.080 and NRS 150.110, the First and Final Account of the Executor is attached to the Petition as Exhibit "1" and incorporated herein and covers the period from February 20, 2020 to May 11, 2020.

IV.

CREDITORS

That, pursuant to NRS 147.010, Notice to Creditors of the Decedent's estate to present their claims within the time and in the manner provided for by law was duly published in the Nevada Appeal, such publication occurred on March 7, 14 and 21, 2020. That the creditors' claim period has expired and no claims have been filed against the estate.

V.

ESTATE

That the Executor filed an Inventory, Appraisement and Record of Value ("Inventory") in this matter, concurrently herewith. Said inventory was mailed to the heirs and devisees of the estate on June 11, 2020. That, as of May 11, 2020, Petitioner found the assets of the estate subject to probate are the real property located at 506 Elizabeth Street, Carson City, NV, with an appraised value of \$316,000.00, 605 W. Spear Street, Carson City, NV, with an appraised value of \$310,200.00 and 1507 Mountain Street, Carson City, NV, with an appraised value of \$303,000.00. Other assets of the estate include miscellaneous household furniture and furnishings, with an estimated value of \$500.00, and a bank account containing approximately \$5,322.94. The First and Final Account attached to the Petition as Exhibit "1" covers the period of February 20, 2020 to May 11, 2020.

VI.

FEDERAL TAX LIABILITY

That the Executor will be filing the personal income taxes for the Decedent. Because the total value of the estate is below the federal estate tax filing requirement, no Estate Tax Return, Form 706, is required for this Estate. Further, the income earned in the estate account will be below the \$600.00 required for filing a Fiduciary Tax Return, Form 1041. Thus, no estate taxes will be owed.

That all acts taken by the Executor have been taken in the best interests of the estate and all acts should be approved and confirmed by the Court.

That the Executor and said law firm agreed that the rate of compensation for the legal services would be Three Hundred Twenty-Five and No/100 Dollars (\$325.00) per hour for services performed by an attorney and One Hundred Twenty-Five and No/100 Dollars (\$125.00) for services performed by a paralegal, plus costs, if any. That said firm has rendered legal services in connection with the representation of the Executor from October 30, 2019, through present, and an itemization of said services is attached to the Petition as Exhibit "2." That the nature and extent of services rendered consists of communications with the Executor, preparation of all court documents, review of the documentation on behalf of the estate and appearance at hearings on behalf of the Executor. That the Executor hereby requests that this Court grant the within application and order payment of Six Thousand One Hundred Forty-Eight and
